Notice of road closure, Culworth Road, Chipping Warden

High Speed Two (HS2) is the new high speed railway for Britain. If you have any questions about these works, please contact our Helpdesk to find out more. You can sign up for regular updates in your local area at www.hs2innorthants.co.uk.

What are we doing?

A section of Culworth Road, near Chipping Warden, will be closed for approximately one month in March 2024. This closure is required for us to build a new farm access road which will join onto Culworth Road.

As part of the HS2 railway design, a section of Culworth Road will be permanently closed, and the new farm access forms part of the preparations for this. Further information about the permanent closure will be communicated when details are confirmed.

In order to re-open the road as quickly as possible, some extended working hours and weekend working may also take place.

When will these works take place?

A section of Culworth Road will be fully closed 24-hours a day from, Thursday 4 March to Sunday 31 March 2024 until the work is complete.

Duration of works

Works will take place from Thursday 4 March to Sunday 31 March 2024

24-7 full road closure.

Normal working hours:

Mondays to Fridays

8am – 6pm

Saturdays

8am - 1pm

Our contractors may be on site for one hours' start-up and shutdown either side of these times.

Weekend working may be required.

What to expect

Varied activities with both quiet and busier periods.

Noise from plant and equipment used for the works.

What we will do

Manage any environmental impacts, such as traffic and noise.

Respond promptly to any complaints and take appropriate action.

Take care to respect the community.

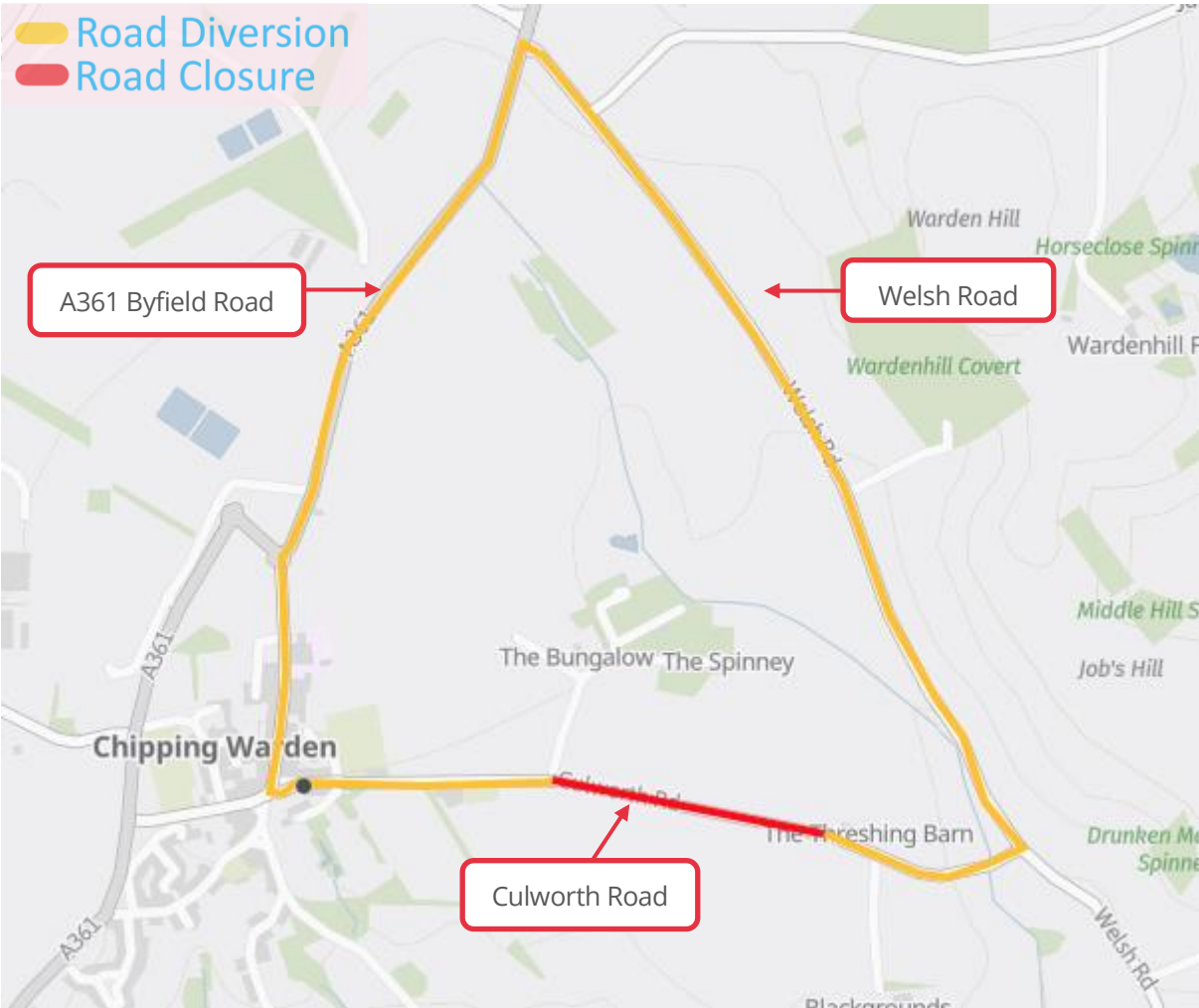

Wardington Road and Culworth Road closures in 2024

Culworth Road and Wardington Road are two small country lanes located to the south of Chipping Warden. They are both used as local access routes to travel to other villages in the area, such as Culworth and Wardington. As well as popular cycling and horse riding routes for local residents. To avoid disruption, we will avoid closing both roads at the same time.

Further closure dates are still being confirmed and subject to local authority approval. When our plans are finalised, we will provide further information and liaise closely with local landowners and businesses.

Wardington Road

February 2024

In February this year we began a one month closure to prepare Wardington Road for the construction of the viaduct near Trafford Bridge. The road will re-open once work is complete and access will be available for the planned equestrian events at the Edgcote Estate.

Summer 2024

In early summer, we plan to close Wardington Road for a period of approximately 5 months. During this closure we will alter the gradient of the road so that the road surface is at the correct height where it passes under the viaduct. We will also install the concrete beams for the viaduct deck, which go over the road.

Culworth Road

March 2024

This works notice explains that Culworth Road will be closed for approximately 4 weeks in March while we build a new entrance to Blackgrounds Farm. The road will then remain open during the spring and summer.

Winter 2024

Towards the end of the year the road will close for approximately 8 weeks while we divert utilities.

In line with the HS2 design, where the railway passes through Culworth Road, a section of the road will be permanently closed in early 2025.
